


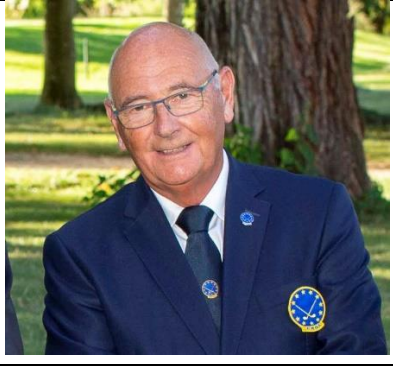


# ESGA board and administration

The ESGA is administered by the ESGA Board. This Board meets at least twice a year: prior to the General Assembly during the ESGA Senior Team Championship & Cup and at the end of a calendar year. More often if necessary. The members of the ESGA Board are appointed by the General Assembly. There is a President, a Vice President, a General Secretary, a Treasurer, a Referee and a member for communication. Each member is chosen for three years with the possibility of reelection until the age of 80 has been reached.

Besides the administration of the ESGA and its final approval of the two tournaments, an important matter is the investigation if a candidate new country complies with the membership criteria of ESGA. The most important criteria are: the Senior Golf Association must be acknowledged by their National Golf Federation as an association representing senior golf in their country. Further, they should be capable to organize an ESGA Senior Team Championship & Cup or an ESGA Masters Team Championship & Cup + Super Masters Team Trophy, which implicates the availability of two nearby and excellent golf courses as well as sufficient qualified members to send in teams. On proposal of the ESGA Board, the General Assembly decides upon new memberships.
